## **Summer Session Tuition**

The summer session is optional for students. Undergraduate courses offered during the summer session are charged per credit. Tuition per credit is 1/60th of the annual tuition payable by students based on their tuition waivers. Students pay the applicable tuition calculated based on the total credits of the courses they take during the summer session. English Preparatory Program students who plan to take courses in their respective levels during the summer session are required to pay only half of the applicable semester tuition based on their tuition waivers. However, the summer session tuition is waived for students who started the English Preparatory Program at the "A2" level and successfully completed the "B1" level by the end of the Spring semester in their first academic year. These students may attend "B2" level courses free of charge during the summer session.

## TL Kuru ve Ödeme Tutarı

Ödemeler, banka aracılığıyla tahsil edilir; Üniversiteye doğrudan ücret ödemesi kabul edilmez.

ABD doları bazında belirlenen ücretlerin TL ödemelerinde; Güz dönemi için Ağustos, Bahar dönemi için Ocak, yaz dönemi için Mayıs ayının ilk 5 iş günü için TC Merkez Bankasının belirlediği döviz satış kurlarının en küçük ve en büyük olanı dışındaki kurların aritmatik ortalaması alınarak hesaplanacak TL karşılıları geçerlidir.

## **Installment Plan**

In case of installment plans, tuition is divided by the number of installments and is paid in equal amounts.

- \* Excluding the programs offered by the Faculty of Aviation and Aeronautical Science.
- \*\* The tuition of the Preparatory Program for international students admitted to the Undergraduate Professional Flight and Undergraduate Law Programs in the 2013-14 academic year is \$ 8,900 including VAT for the 2017-2018 academic year.
- \*\*\* Excluding the Undergraduate Law, Undergraduate Architecture, and Undergraduate Civil Engineering Programs. The tuition is \$12.000 for the Undergraduate Law Program, and \$8,900 for the Undergraduate Architecture and Undergraduate Civil Engineering Programs.
- \*\*\*\* The flight training fee is not included in the annual tuition of the Professional Flight Program. Students are required to pay a separate flight training fee to the University's partner institution in 3 equal installments at the beginning of the 4th, 6th and 8th semesters in their undergraduate programs. The flight training fee is determined annually by the flight school. Students are charged the flight training fee starting from the 4th semester in their undergraduate programs. For students admitted in 2013, the flight training fee is 27,000 EURO including VAT.
- \*\*\*\*\* Undergraduate Gastronomy and Culinary Arts students who will matriculate to their undergraduate program in the 2017-2018 academic year must obtain their uniforms and knife sets at the beginning of the 2nd semester of their freshman year when their culinary courses start. The uniforms will be obtainable from the on-campus bookstore, and the knife sets will be obtained from the University's contracted firm. For the 2017-2018 academic year, the cost of the uniforms is 213 TL, including VAT, and the cost of the knife sets has been set as 660 Euros including VAT.
- \*\*\*\*\*\*\* Undergraduate Hotel Management students who will matriculate to their undergraduate programs in the 2017-18 academic year must obtain their uniforms from the on-campus bookstore at the beginning of the 2nd semester of their sophomore year when their culinary courses start. The cost of the uniforms is 188 TL including VAT for the 2017-2018 academic year.
