**Summer Session Tuition**

The summer session is optional for students. Undergraduate courses offered during the summer session are charged per credit. Tuition per credit is 1/60th of the annual tuition payable by students based on their tuition waivers pay the applicable tuition calculated based on the total credits of the courses they take during the summer session. English Preparatory Program students who plan to take courses in their respective levels during the summer session required to pay only half of the applicable semester tuition based on their tuition waivers. However, the summer session tuition is waived for students who started the English Preparatory Program at the "A2" level and successful the "B1" level by the end of the Spring semester in their first academic year. These students may attend "B2" level courses free of charge during the summer session.

**TL Rate and Amount Due in TL**

Fees are paid on a semester basis. Payments are collected in TL through banks. The university does not accept direct cash payments.

**Installment Plan**

In case of installment plans, tuition is divided by the number of installments and is paid in equal amounts.

\* Excluding the programs offered by the Faculty of Aviation and Aeronautical Science.

\*\* The flight training fee is not included in the annual tuition of the Professional Flight Program. In addition to the annual tuition of the Undergraduate Professional Flight Program, students pay a separate fee for their required flight training. The flight training fee is paid to the University's partner flight school "Ayjet Anatolian Stars" in 3 equal installments at the beginning of the 4th, 6th and 8th semesters in the undergraduate program. The flight training fee is determined annually by the Flight School. Students are charged the flight training fee starting from the 4th semester in their undergraduate programs. The Flight School has set the flight training fee for the 2017-2018 academic year as 54,000 EURO including VAT. The fee must be paid in Turkish Lira. For recipients of tuition waivers, the University covers the flight training fee up to the rate of the tuition waiver the student has been awarded.

\*\*\* Undergraduate Gastronomy and Culinary Arts students who will matriculate to their undergraduate program in the 2017-2018 academic year must obtain their uniforms and knife sets at the beginning of the 2nd semester of their freshman year when their culinary courses start. The uniforms will be obtainable from the on-campus bookstore, and the knife sets will be obtained from the University's contracted firm. For the 2017-2018 academic year, the cost of the uniforms is 213 TL, including VAT, and the cost of the knife sets has been set as 660 Euros including VAT.

\*\*\*\* Undergraduate Hotel Management students who will matriculate to their undergraduate programs in the 2017-18 academic year must obtain their uniforms from the on-campus bookstore at the beginning of the 2nd semester of their sophomore year when their culinary courses start. The cost of the uniforms is 188 TL including VAT for the 2017-2018 academic year.
